Held Mabel's Power of Attorney in the last 10 years of her life after Robert exiled from Malta. Deputy Leader of the Nationalist Party throughout the troubles in the 1970s. Later President of Malta 1999-2004. Died 2010.	
	Prof Joseph Ganado	Originally a top civil lawyer with Ganado & Associates one of Malta's largest legal practices. Died 2016. Uncle exiled to Uganda during WW2 for his safety as a leading Italian sympathiser and blamed Stricklands for this.
